Official transcripts must come directly from the issuing high school in a sealed envelope. Transcripts will be considered unofficial if the envelope has been opened. You may send a copy of the transcripts with your enrollment application or you may contact your previous high school(s) to request the transcript(s) be mailed to us. We will contact you once the transcript has been evaluated to inform you of the results and of any possible changes to the enrollment contract which you must approve. Please allow at least three business days to process. **Check here if you have previously sent your transcript to American School for evaluation.**

If American School does not have a copy of your transcript(s) at the time of enrollment, we will tentatively set up your program based on the information you provide below. We will then request your transcript(s) from the school(s) you listed above. We can only allow access to one course until credits have been verified. This will prevent possible duplication of courses. We cannot finalize your program until we have received and evaluated an official transcript.

AMERICAN SCHOOL'S TUITION SETTLEMENT POLICY

We believe you will be pleased with your American School studies; however, should you decide within the first ten days after your enrollment is accepted that you wish to discontinue your studies, you must:

1. Notify American School **in writing** that you wish to cancel.
2. Return al of your study materials, if possible, in a new, unused condition. Your request will be honored and a refund of all money you have paid will be sent to you.

American School has established a liberal refund policy for your protection. If, after the initial ten day period described, you should decide to cancel for any reason, tuition charge will be based on how much of the course you have completed as follows:

From ten days after enrollment is accepted and until the time the school receives the first completed assignment from you, upon cancellation, the school is entitled to retain a registration fee of \$75.00.

After American School receives your first completed unit exam and until you complete half the program, if you request cancellation, the school is entitled to the registration fee of \$75.00 and a charge which

shall not exceed the following:

1. Up to and including completion of 10 percent of the program, 10 percent of the tuition minus the registration fee.
2. After completing more than 10 percent of the program and up to and including 25 percent of the program, 25 percent of the tuition minus the registration fee.
3. After completing more than 25 percent of the program and up to an including completion of 50 percent of the program, 50 percent of the tuition minus the registration fee.
4. If you complete more than half of the program, the school shall be entitled to full tuition.

If prior to notifying American School of cancellation, you have paid more than the amount required under the cancellation formula, the excess will be refunded to you within thirty (30) days. If you have paid less than the amount required under the formula, you must pay the balance due within thirty (30) days.

In case of illness or accident, death in the family, or other circumstances beyond your control, you shall be entitled to special consideration and the school may settle the account for an amount which is a lesser charge to you than that called for by the school's established policy.

STUDENT'S RIGHTS AND RESPONSIBILITIES

American School agrees to provide you with a high school education by the use of textbooks and digital media similar to materials used by other high schools, supplemented by study guides especially developed for home study use. The tuition covers registration, instruction, all text and digital materials, consulting privilege, and postage on all material sent to me (U.S. locations only).

The minimum number of credits to be taken to obtain an American School diploma is 4 1/2. The price of the program depends on the ability of American School to verify the number of credits you have claimed through transcripts from schools attended. You will be allowed a \$100.00 tuition reduction for each verified credit. The school agrees to make an allowance for previous high school credits except for physical education, driver's education, religion, performing arts (chorus, band, drama, etc.) or ROTC.

Study materials will be sent in a timely manner so that courses should be available in advance of rate of progress. Should you need lessons at a faster pace, you may notify American School in writing, giving the reasons why you requires more rapid service. All such requests will be reviewed by the Student Service Department. You may need to make additional financial arrangements if you are requesting coursework at an accelerated pace.

You may take up to two online courses per year at no additional cost. Additional full-unit online courses can be purchased for \$190 each, and half units of online courses for \$170 each. If you wish to transfer to the full online high school diploma program, you must notify American School in writing. All requests will be handled by the Student Service Department.

If you have selected a monthly installment tuition plan, all payments must be made when due regardless of your study progress.

American School agrees to allow you four years, if necessary, to complete this program. During that period, the school stands willing and ready to render such service as you may request in form of supplementary instruction and suggestions. **This contract will cease to be in effect four years from the original date of acceptance, and no requests for refunds will be considered thereafter.**

Upon completion of the program, you may find it necessary to take a qualifying exam administered by the state, college, or a pre-professional school, or other agency. In the event that such an exam is taken within six months after completion of the program, and you do not meet standards in any subject or course covered by the high school program, American School agrees to refund your money or give additional training at no additional cost in the areas needed.

Upon successful completion of all academic and financial requirements, a diploma from American School, a school which is accredited by the Middle States Association of Colleges and Schools Commissions on Elementary and Secondary Schools (MSA-CES), National Council for Private School Accreditation (NCPA) and Accreditation International (Ai), and is recognized as a non-public secondary school by the Illinois State Board of Education, will be awarded to you.
